ARTICLES OF INCORPORATION OF

The undersigned persons, for the purpose of forming a non-profit corporation under the laws of the State of Arizona, hereby adopt Articles of Incorporation as follows:

#### ARTICLE I

NAME OF CORPORATION

ARIZONA CORP. COMMISSION

#### **PURPOSE**

The purpose for which the Association is organized is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Arizona, as they may be amended from tine to time, and specifically but not in limitation thereof, the corporation shall be organized and operated as a real estate management association as defined in Section 528 of the Internal Revenue Code of 1954, as amended, to provide for the acquisition, construction, maintenance and care of the Condominium, consisting of residential Units and Common Elements within that certain subdivision more particularly described in the Condominium Declaration for Rancho North, a Condominium, (hereinafter called the "Declaration"), applicable to the property and recorded or to be recorded in the Office of the Maricopa County Recorder, as the same may be amended from time to time as therein provided.
