ARTICLES OF INCORPORATION

OF

WINDROSE AT ZANJERO TRAILS COMMUNITY ASSOCIATION INC.

#### ARTICLE I ENTITY NAME

The name of the corporation is the WINDROSE AT ZANJERO TRAILS COMMUNITY ASSOCIATION INC. (hereinafter called the "Association").

## ARTICLE II DEFINITIONS

Terms used but not defined in these Articles shall have the meaning subscribed to such terms in that certain <u>DECLARATION OF COVENANTS</u>, <u>CONDITIONS</u>, <u>RESTRICTIONS</u>, <u>ASSESSMENTS</u>, <u>CHARGES</u>, <u>SERVITUDES</u>, <u>UENS</u>, <u>RESERVATIONS</u> AND <u>FASEMENTS</u> FOR <u>WINDROSE</u> AT <u>ZAMIERO TRAILS</u>, recorded in the Official Records of Maricopa County, Arizona, as the same may be amended from time to time (the "Declaration").

# ARTICLE III NONPROFIT CORPORATION

The Association is formed as a non-stock, nonprofit corporation under the laws of the State of Arizona.

## ARTICLE IV PRINCIPAL OFFICE

The mailing address of the initial principal office of the Association is 6720 North Scottsdale Road, Suite 250, Scottsdale, Arizona 85253-4424.

# ARTICLE V PURPOSE AND POWERS OF THE ASSOCIATION

The Association is organized in accordance with, and shall operate for nonprofit purposes pursuant to Arizona law. The Association is formed for the purpose of exercising all of the powers and privileges, and performing all of the duties and obligations, of the Association as set forth in the Declaration. Without limiting the generality of the foregoing, the Association is organized for the following general purposes:

1

- (a) to fix, levy, collect, and enforce payment by any lawful means all charges or assessments arising pursuant to the terms of the Declaration;
- (b) to pay all expenses incident to the conduct of the business of the Association, including all licenses, taxes, or governmental charges levied or imposed against the Association's property; and
- (c) to have and to exercise any and all powers, rights, and privileges which a corporation organized under Arizona law may now, or later, have or exercise.

The above statement of purposes shall be construed as a statement of both purposes and powers. The purposes and powers stated in each of the clauses above shall not be limited or restricted by reference to, or inference from, the terms and provisions of any other such clause, but shall be broadly construed as independent purposes and powers.

#### ARTICLE VI STATUTORY AGENT

The Association hereby appoints AGS LLC, an Arizona limited liability company, whose address is 6720 North Scottsdale Road, Suite 250, Scottsdale, Arizona 85253-4424, as its lawful statutory agent upon whom all notices and processes, including service of summons may be served, and which, when served, shall be lawful, personal service upon the Association (the "Statutory Agent"). The Association may, at any time, appoint another Statutory Agent and the filing of each appointment shall revoke this or any other previous appointment of the Statutory Agent.

#### ARTICLE VII MEMBERS

Membership in the Association shall be dependent upon ownership of a qualifying property interest as defined and set forth in the Declaration. Any person or entity acquiring such a qualifying property interest shall automatically become a member of the Association, and such membership shall be appurtenant to, and shall run with, the property interest. The foregoing shall not be deemed or construed to include persons or entities holding an interest merely as security for performance of an obligation. Membership may not be severed from or in any way transferred, pledged, mortgaged, or alienated except together with the title to the qualifying property interest, and then only to the transferee of title to said property interest. Any attempt to make a prohibited severance, transfer, pledge, mortgage, or alienation shall be void.

### ARTICLE VIII VOTING RIGHTS

Voting rights of the members of the Association shall be determined as set forth in the Declaration.

### ARTICLE IX INCORPORATOR

The name and street address of the incorporator is SBH ZANJERO TRAILS LP, an Arizona limited partnership, whose address is 6720 North Scottsdale Road, Suite 250, Scottsdale, Arizona 85253-4424 (the "Incorporator"). All powers and duties of the Incorporator shall cease at the time these Articles of Incorporation are delivered to the Arizona Corporations Commission. To the fullest extent permitted by Arizona law, the Incorporator shall in no event by liable to the Association or its members for any action or failure to act taken by the Incorporator. No amendment or repeal of this Article shall apply to or have any effect on the liability or entitlement to indemnification or defense of the Incorporator with respect to any act or omission of the Incorporator occurring prior to any such amendment or repeal.

## ARTICLE X BOARD OF DIRECTORS

The affairs of the Association shall be managed by an initial Board of Directors consisting of three (3) individuals, who need not be members of the Association. The Board shall fulfill all of the functions of, and possess all powers granted to, boards of directors of nonprofit corporations pursuant to Arizona law. The number of Directors of the Association may be changed by amendment of the Bylaws of the Association. The names and addresses of the persons who are to act in the capacity of initial Directors until the selection of their successors are:

Each of the foregoing persons has consented to serve as a Director. The Board may delegate its operating authority to such corporations, individuals, and committees as it, in its sole discretion, may determine, as set forth in the Declaration.

# ARTICLE XI LIMITATION OF DIRECTOR LIABILITY

A Director of the Association shall not be personally liable to the Association for monetary damages for any act or omission in his capacity as a director, except to the extent otherwise expressly provided by Arizona law. Any repeal or modification of this Article shall be prospective only, and shall not adversely affect any limitation of the personal liability of a director of the Association existing at the time of the repeal or modification.

## ARTICLE XII INDEMNIFICATION

Each person who acts as a Director, officer or committee member of the Association shall be indemnified by the Association against any costs, expenses and liabilities which may be imposed upon or reasonably incurred by him in connection with any civil or criminal action, suit or proceeding in which he may be named as a party defendant or in which he may be a witness by reason of his being or having been such Director or officer or by reason of any action alleged to have been taken or omitted by him in either such capacity. Such indemnification shall be provided in the manner and under the terms, conditions and limitations set forth in the Declaration or Bylaws of the Association.

## ARTICLE XIII AMENDMENT

These Articles may be amended only upon a resolution duly adopted by the Board of Directors and approved by a vote of the Members holding at least two-thirds (%) of the total number of votes in the Association; provided, however, that until expiration or termination of the Declarant Control Period, the written consent of the Declarant shall also be required; provided further that such vote of Members is not required with respect to any amendment to these Articles adopted for the sole purpose of complying with the requirements of any governmental or regulatory agency or any institutional lender authorized to fund, insure, or guarantee mortgages on Lots or Condominium Units, which amendments may be adopted by the Board of Directors without a vote of the Members, but otherwise approved by the Declarant until expiration or termination of the Declarant Control Period.

By the signature appearing below, the entity named in Article VI as the Statutory Agent and in Article IX as the Incorporator above hereby acknowledges under penalty of perjury that

this document together with any attachments is submitted in compliance with Arizona law. In addition, by its signature below, the entity named in Article VI as the Statutory Agent accepts the appointment thereof and acknowledges that the appointment is effective until the Association replaces the Statutory Agent or the Statutory Agent resigns, whichever occurs first.
